Sir,

With due regards, I beg to state that today on 18/08/2024 at about 3.20 a.m received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foothill of Uyok Ching Leirongthel Pitra near Water Tank for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 5/9 Gorkha Rifle led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 4:10 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 1(one) no. of SMG Carbine bearing registration No. 15228367 with magazine, (2) 1(one) no. of 12 Bore Single Barrel, (3) 1(one) no. of 9mm Pistol bearing registration No. R-7182 with magazine, (4) 1(one) no. .32 Pistol bearing registration No. R-3527 with magazine, (5) 6(six) nos. of 36 HE Hand Grenade(which can be used as explosive), (6) 1(one) no. of Chinese Hand Grenade, (7) 2(two) nos. of Detonator, (8) 3(three) nos. of Arming Ring, (9) 2(two) nos. of Tube Launching, (10) 2(two) nos. of Grenade Mark-III A2, (11) 19(nineteen) nos. of 7.62 x 51 mm live ammunitions, (12) 20(twenty) nos. of 7.62 x 39mm ammunitions, (13) 12 nos. of 9mm live ammunitions, (14) 2(two) nos. of .32 mm live ammunitions, (15) 5(five) nos. of Ballistic Cartridge (16) 5(five) nos. of Explosive Cartridge, (17) 2(two) nos. of 12 bore Cartridge, (18) 5(five) nos. of Tear Smoke Shell SR, (19) 1(one) no. of Stun Grenade, (20) 1(one) no. of BP Patka and (21) 1(one) no. of Baofeng Walkie Talkie set with Charger from the spot i.e. Uyok Ching Leirongthel Pitra at @ 5:00 am and seized at 05:10 am by observing necessary formalities. The massive searched Operation was conducted from 4:10 am to 6:10 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
