Sir.

With due regards, I beg to state that today on 29/07/2024 at about 4.00 a.m. received a reliable input by 165 TA that .: ome unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foothill of Pechi Chinglak nearby Bridge for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 4-AR, COB-Thoubal led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 5:00 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 5(five) nos. of 36 Hand Grenade, (2) 1(one) no. of SLR Magazine. (3) 1(one) no. of 40 nm Lathod Shell, (4) 1(one) no. of Detonator, (5) 1(one) no. of Green Smoke Shell, (6) 1(one) no. of LR Smoke Shell, (7) 1(one) no. of Tear Smoke Shell, (8) 24 (twenty-four) no. of 7.62x54 live round, (9) 1(one) no. of 9mm live round, (10) 1(one).no. of .32mm live round, (11) 15(fifteen) nos. of 7,62 x 52 mm fire out cartridge, (12) 15 (fifteen) nos. of 7.62nm fire out cartridge, (13) 12(twelve) nos. of 9mm fire out cartridge, (14) 10 (ten) nos. of 5 56mm fire out cartridge, (15) 7(seven) nos. of HD cartridge and (16) 3(three) nos. of unmark fire out cartridge from the spot at 6:30 am. The massive searched Operation was conducted from 5:00 am to 7:00 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
