

Subject: - Report.

Sir,

I am to report that today i.e. 14/08/2024 at 04:00 am received a reliable information that some unknown armed miscreants have been hiding some arms, ammunitions and explosive substances at Yairipok Gwarok hill for offensive act against Security Forces and CAPF in c/w upcoming Independence Day 2024.

On receipt of the information, Special Operation Group (SOG) Thoubal district Police along with personnel of 105 Bn. BSF stationed at Yairipok PS, 5/9 Gorkha Rifle Thoubal Tomching, 4 AR COB Somrei, OC/CDO-TBL, Golf-52 CDO/TBL, led by Inspt. N. Suresh Singh, OC/YPK-PS under the command of Shri H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri. Rakesh Balwal, IPS, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 04:40 am by using metal detectors. On searching the following articles i.e. (1) 1 (One) No. of 5.56 mm INSAS Rifle, Body No. 18245321 along with one magazine. (2) 1 (one) No. of 12 Bore Single Barrel gun with Body No. 11340 (3) 1 (One) No. of .32 Pistol with Body No. M5944 along with magazine (4) 5 (five) nos. of 36 HE Hand grenade without detonators along with 02 Arming ring (5) 1 (One) No. of Tube launching (6) 2 (two) nos. of MK-III A2 gren (7) 1 (one) Motorola Walkie Talkie (8) 3 (three) nos. Improvised Explosive Device (IED) weighing in total 7.940 kg approx. (9) 20 (twenty) nos. of 5.56 mm INSAS live rounds (10) 2 (two) nos. of 12 Bore live cartridges (11) 3 (three) nos. 9 mm live rounds & (12) 1 (one) No. of 9mm magazine were found from the spot at 05:04 am. Hence the above noted incriminating articles were seized at 05:15 am by observing formalities. The massive search operation was conducted from 04:40 am to 06:30 am on the same day.

So, I therefore handed over the seized articles to you for your kind taking necessary legal action.
