



Subject: Report

Sir,

I have the honour to report that today i.e., 22<sup>nd</sup> May, 2024 at about 2:00 p.m., received a reliable information from 4 AR Int. team corroborated with our own intelligence about presence of some anti-social elements regarding the presence of some anti-social elements in and around Khurai Kongpal, Imphal-East District. Based on the said information, a team of CDO/IE including woman police personnel led by myself assisted by ASI. Kh. Victor Singh of CDO/IE under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit, under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE and under the guidance of Shri. K. Meghachandra Singh, MPS SP/IE District lunched a searched operation at Khurai Kongpal Ningthoubung Leikai, Imphal East District.

In that, one suspected woman namely: Salam (N) Lourebam (O) Bombem Devi (42 years) W/o - L. Othelo Singh of Khurai Kongpal Ningthoubung Leikai, Imphal East was detained for spot examination at Laihidden Thong, Kongpal Chingangbam Leikai, Imphal East District. On examination, it came to know that she is an active member of the outfit PREPAK (Pro). The detainee stated that she joined the said organisation thorough one Mr. Sanatomba Singh of PREPAK (Pro) in the month of April, 2024 and presently working under his command. A sum of Rs. 35, 000/- (thirty five thousands rupees) and one mobile phone was found and recovered from her possession. She further stated she is directly involved in the extortion of money from the general public for raising their party fund and today on the advice of the said Mr. Sanatomba of PREPAK (Pro), she had collected the above recovered money from a person from Sangakpham Bazar, Imphal East. So, the detainee was arrested from the spot i.e. Laihidden Thong, Kongpal Chingangbam Leikai, Imphal East District at 2:45 p.m. and seized the above recovered; (i) A sum of Rs. 35, 0000/- (thirty five thousands rupees) in the denomination of Rs. 500 X 70 = Rs. 35, 000/- and (ii) one mobile phone (POCCO C31) bearing IMEI no. 868166068560192 & 868166068560200 along with two SIM cards bearing no. Jio - 89918650400099577704 & Vodafone - 8991755261072072389SY from her possession by observing due formalities at 2:55 p.m.

The arrestee (Bombem) disclosed that the said Mr. Sanatomba is waiting for her at Lamlong Bazar. Immediately, our team along with the arrestee rushed to Lamlong Bazar and on the pointing of the arrestee (Bombem) arrested one Kangabam Sanatomba Singh @ Amuba (49 years) S/o (Late) K. Ibocha Singh of Kongpal Laishram Leikai, Imphal East District from Lamlong Bazar near the traffic Island at 3:15 p.m. by observing due formalities and seized (i) One mobile phne (CELLECOR) bearing IMEI no. 356720719783089 & 356720719783097 along with one Airtel SIM card bearing no. 8991160990022973424U, (ii) one mobile phone (Redmi Note 13 Pro) bearing IMEI no. 866083069344389 & 866083069344397 along with one Airtel SIM card bearing no. 8991000920477833538U, (iii) one wallet containing a sum of Rs. 20/- (twenty rupees) and one ATM Card of HDFC Bank and (iv) One scooter (Honda Activa), black in colour, bearing regd. no. MN-06SG/7703 bearing Engine no. JK15E-W-3041029 and Chassis no. ME4JK154JNW041124 were seized from the spot i.e. Lamlong Bazar near the traffic Island at 3:25 p.m. by observing due formalities

Therefore, the arrested persons along with seized items are being handed over to you for taking up further necessary legal action against them.







