
Sir,

I, the undersigned would like to file the following few lines for your kind and sympathetic perusal that, in the ensuing conflict which had erupted on the 3rd of May 2024, I was forced to flee from my private residence at **New Lambulane 3rd Street, P.O./P.S. Porompat, Imphal East** along with my family in a nearby 1st Battalion Manipur Rifles, Imphal West before we were eventually evacuated by the Assam Rifles to Motbung, Kangpokpi.

That, I have left my private residence unattended along with personal jewelleryes worth 15 lacs and 5.5 lacs in cash since our exodus from the said premises. (Details of properties enclosed).

Therefore, you are requested to ensure protection of the said property from illegal occupation, looting and destruction of my homestead by Meitei miscreants.




