I, the undersigned, have the honour to submit the following few lines for your kind perusal and necessary action(s) pleased.

1. That, I am the Managing Director of Diabetes Hospital & Research Centre and permanently residing at Thangmeiband D.M. University Campus, Southern Side, P.O. & P.S. Imphal. District - Imphal West, Manipur. However, I am residing presently at the Diabetes Hospital with my family due to the recent flood inside the D.M. University Campus.

2. That, today i.e. on 07/06/2024 at about 6:30 a.m. two unknown persons gave a polythene packet black in colour (in which included hospital medicines) to one of my staff namely. Thiyam Dina Singh, aged about 21 years, S/o Thiyam Bidyasagar Singh of Nongmeibung, Old Cheekon, Imphal East District, Manipur, who is working as an office assistant in the Diabetes Hospital when he was sitting at the Counter of the Diabetes Hospital for handing over the said polythene packet to me.

3. That, my said staff namely, Thiyam Dina Singh handed over the said polythene packed to me at about 12:00 a.m. and when I received the polythene packed from my staff, it was very heavy and unnatural and I have not made any request for hospital medicines to any other unknown person and as such I felt suspicious and then I informed directly to the Superintendent of Police, Imphal East for immediate help and necessary legal proceedings. Thereafter, some personnel of police commando of Imphal East rushed to the Diabetes Hospital and they opened the polythene packed and found one hand grenade. In the previous occasions, I have been harassed and also threatened to kill by some unknown persons in the last few months.

It is, therefore, prayed that the respected Sir may kindly initiate and take up necessary legal action(s) against the persons involved in the illegal acts/activities.

I shall be grateful for your immediate necessary action.




