The accused person deliberately with malicious intention insults the Meitei/ Meetei religion and religious belief of the Meetei/ Meitei community. Further, he is promoting enmity between Meitei/ Meetei community and other communities on the ground of religion.

The complainant came to know about the existence of the above acts committed by the accused person on 6.6.2024 at Imphal.

The acts of the accused person violates Indian laws, which is punishable offenses under Section 117 IPC (abetment), Section 295-A IPC (insulting religious sentiments), Section-153-A IPC (promoting enmity between communities) and any other relevant provisions of law.

The unlawful activities of the accused person and his associates amounts to anti-national that challenged the integrity and sovereignty of India and is fit to deal under the relevant provisions of Unlawful Activities (Prevention) Act and other relevant provisions of law. As there is high possibility of the accused linked with Khalistan movement, Canada, ISI, Chinese etc. and also with narco-terrorist group whose activities are currently actively undergoing in the State of Manipur; call records of the accused, financial activities of the accused for any misappropriation, personal assets and its sources etc. may kindly be investigated.

In view of the above narrated facts and circumstances, proper investigation against the accused person and his associates are required to be initiated immediately for his criminal offence by registering an FIR. It is further to add that in view of the factual circumstances, the concerned authorities/ cybercrime cell also requires to block accused, Uday S Reddy's X or Twitter account in India i.e. @Kautilya33. Further, issuance of lookout circular (LOC) or equivalent alert for monitoring entry and exit points in India is also required to be initiated immediately with regards the above-mentioned accused persons thereby communicating his workplace describing the criminal acts committed by him against India.

The complainant came to know about the existence of the above acts committed by the accused persons on 6.6.2024 at Imphal. The session was recorded on January 14, 2024 and one Vishwajeet Singh @VishuAdv on X, formerly Twitter which is available at https://twitter.com/VishuAdv is also actively involved.

The above whole conversation and open plan to block the river water in Manipur is based on wild allegations that Meiteis have cut off power supply to Hill areas without any proof and evidence to support the same. But the fact is that there is no such attempt of obstructing or cutting off power supply by Meiteis especially to any of the Hill areas.

In continuation/ addition of the above notorious activities, the accused person, Uday S Reddy, on 29th May, 2024, uploaded the following statements/ words in his X account -

"Is the Meitei religion good for anything? What does it preach actually? (That is a genuine question, not rhetorical.)"

There is a for information of all of us and you may have heard in the news here and there sometime. There is a water sharing agreement between so many States. There is a Godavari water sharing agreement between Karnataka and Tamil Nadu. There is a Indus and the other river that flows from Punjab and goes to Pakistan, there is a Indus and what is the name of that river, very famous river big river VIAS, Indus and Vias water sharing agreement with Pakistan, which India have threaten many times to revoke or terminate that agreement as a diplomatic measure. So, there is a water sharing agreement between Haryana and Punjab. There is a water sharing agreement between Himachal and Punjab. There is a water sharing agreement between Jammu & Kashmir and Punjab. There is a water sharing agreement between Uttarakhand and Uttar Pradesh, after the formation of Uttarakhand. OK This is one thing which I am suggesting here that we should even start talking to the leaders/ leadership as well. We should have a we should put it out that we will stop the water, if they can stop the electricity then we can stop the water by doing whatever is required. Its easy to stop water in the mountains and disturb the water supply. We can do that, that can be done by the people. So, this should immediately come up as the next proposal by tomorrow and that we need to have a water sharing agreement with the Imphal valley as they we are already having a de facto separation. De facto separation is already there, our people cannot go to the valley their people cannot come and you know come to the hill areas and return unassaulted or unmolested. So, we can do that, we should start saying it from tomorrow itself. This is my suggestion on this. It is OK Gaintslayer?

: No, I was saying, I was just trying to thank you know when Vishwajeet putting legal term legal way its some more legalised, which we can do without harming anybody or without going the other way. You know the not the legal way, like aaa that is a very good suggestion. So, my dear twitter warriors I think we need to do something about it. S..... Somewhere there .....resources are there. Ok I wanted them on this space but may be there be see. So, that is a good suggestion. Thank You Gaintslayer and Vishwajeet. Thank you so much. Who is next, Enncee. ....

Enncee

: Yes, Thank you Kim .. Kautilya please go ahead.

Kautilya33 (Speaker) : Right so I endorsed Vishwajeet's point about asking for a water sharing agreement. Aaaa It may not happen but at least did down and give them an alert that.

Vishwajeet....

: No, it will put some pressure, it will put some pressure. I am not saying it will happen overnight but it will pressure on them not to do such stupid things in future, like cutting of electricity etc. like this disturbing electric supply etc.

Kautilya33 (Speaker): Ya. But on the other hand, physically blocking the water is not aaaa is generally not feasible because you need to built a big Dam and even than it will have a limited capacity and after that little flow flow right. I mean, Modi Government threaten Pakistan that will ....will.....

Vishwajeet ....

: Yes Yes, I know that. Dams have to be built but we can just threatening is does no ... I mean they have been threatening about so many things, we can also threaten.

Kautilya33 (Speaker) : Ya. OK

Vishwajeet.... : Threatening is Fine ya.

Kautilya33 (Speaker) : Ya. That's all I wanted to say. But actually, blocking the water is physically not possible

Overlapping one another - Possible .....

The accused persons use a loophole in the Wikipedia entry process - this online encyclopaedia needs sentences to be attributed. Uday S Reddy, by attributing only cherry-picked articles that make allegations only against the Meiteis and leaving the Kukis of any wrongdoing, spoiled the peace process undertaken by the State Government.

It is known to all that Wikipedia is a handy platform used by millions of people around the world. They refer to it as an initial rough guide on topics. By wrongly presenting the Meiteis, Manipur Government, the BJP, the Indian Government, and Prime Minister Narendra Modi in the context of the Manipur violence, the accused, Uday S Reddy is liable for criminal prosecution under the various provision of law enforced in the country.

The sudden large-scale violence that erupted at Churachandpur on 3<sup>rd</sup> May, 2023 which spreads to other parts of the State was the result of well thought and planned by the Kuki terrorists for the last many years. Though at the early part of violence the Kukis fooled the outside media a result of direction of High Court for inclusion of Meitei to Scheduled Tribe list.

It is pertinent to mention herein that the Supreme Court on November 2023 also pointed out that some people and groups in Manipur only want to "keep the pot boiling". It is beyond any doubt that the accused, Uday S Reddy is one of the persons included in keeping the "pot boiling". The accused continues to run and participate in X sessions with Kukis and guide them on how to protest and threaten the native valley people (Meiteis).

On January 15, 2024, accused, Uday S Reddy participated in the discussion of Twitter Warriors thereby discussing and explaining to the Kukis how to block water flow from the Hills of Manipur to the Imphal valley and also to have a Water Sharing Agreement to threaten the valley people especially Meiteis so as to create more tension among communities. "Vishwajeet ....

Gaintslayer is saying that if they are in a position to deny us the electricity, then we are in a position to deny them the water resources. All the rivers as a natural phenomenon, rivers flow from the hills to the plans and valleys. That is a natural phenomenon and we should start also start a campaign on this that we will not share the water ... water resources with the valley and if the valley really needs access to the water which is coming from the hills. Then we need to have water sharing agreement with Imphal. OK This is what the Gaintslayer was suggesting and which I am putting in the right perspective here.

The State of Manipur has been suffering from violence since 3rd May, 2023 but the violent activities of the Kuki-Zo communities were visible since the early part of March, 2023, such as burning down of Forest Offices at Churachandpur, vandalising open Gym etc. which has been continuing till date in different forms. On 3rd May, 2023, the violence act of Kuki-Zo suddenly escalated thereby naming the same as an ethnic clash between Meitei community and Kuki Community. The accused person has also been speaking regularly since May 3, 2023, on Spaces sessions on X. He instructs people how to harass the Meiteis and do acts that will keep ethnic tensions alive and the pot boiling. His Wikipedia edits are attributed to only questionable news sources that speak in favour of the Kukis and against the Meiteis. He does not attribute to neutral or objective sources, so he is able to paint a misleading picture of the Meiteis. This will anger the Meiteis and abetted the Meiteis for retaliation.
