Certain details like name, address and phone kept pouring in from different sources regarding the individuals seen in the disturbing video. The video also got viral and our organization got immense pressure from numerous animal lovers across the state to act against the individuals.

Actually, the act seen in the video is very inhumane and crossed every limit of cruelty. The cat was seen crying in pain as it was hit repeatedly by the sharp side of the kitchen turner. Unsatisfied, the individual again kick it so hard it flew out of the house and hit a bamboo tree. General public is in stern dismay due to the video. In a brief communication with us with the individual on his Facebook account, he pleaded guilty.

I therefore request you kindly to take up stern action the individuals as per Sec. 428 & 429 of IPC, 11 (a) of Prevention of Cruelty of Animals Act and other prevailing cyber laws.
