No. 170724/PN01 with the heading of "MANIPUR MEITEI PANGAL REVOLUTIONARY ARMY" which is written in Manipuri language and English alphabet. The press released when translated states that on 16<sup>th</sup> July, 2024 a new organization namely "MANIPURI MEITEI PANGAL REVOLUTIONARY ARMY" has been formed by collecting main power from different Meitei Pangal inhabitant areas of Manipur having 2430 members. The aims of the organization is to rectify/punish the Meitei Pangals who work out of Islam law like selling drugs, using drug, corrupted

Government/Private employee, sucking of the blood from the poor by lending money etc. The organization will rectify/punish only Meitei Pangal community and warned other organizations & other communities of Manipur not to meddle in the matters of selling and the consumption of drugs in the Meitei Pangal Community. The drug sellers, drug users, who work out of Islam law should surrender to them and promise by holding Quran not to repeat such business. Anybody who does not hit their directions will be punished by cutting off their neck in front of public. The drug sellers and users are warned to surrender before the organization by 30<sup>th</sup> July. The Organization also warned the other Communities/Organizations not to come to Meitei Pangal areas for using drugs and to conduct business of drugs. If other Communities/ Organization will come, they will be punished by the Organization. The Drug king pin family members of Md. Taj Khan @ Md. Nawash, along with his wife Rina, father-Abothem, Mother-Mumtaz @ Ehem and younger brother Md. Shahid residing at opposite to Lilong Alia Madrassa should surrender to the organization on or before 30<sup>th</sup> July 2024. If not surrender the organization will kill them by cutting of their neck. The above mentioned press release is signed by one Sarif Hussain, Publicity and information Secretary of MANIPURI MEITEI PANGAL REVOLUTIONARY ARMY, which is likely to be alias. A screen shot of the facebook post and press released is taken and enclosed.

It is clear from the contents of the press released that, the said organization has threatened the different Communities of Manipur and other organizations stating that if any organization or general public disobey their rules and regulations they will kill by cutting off their neck. The contents of the above mentioned press released is highly suspected to be criminal conspiracy with the common intension to cause mistrust among the different communities. The above mentioned press released has the high potential and clear intension to disturb the peace and communal harmony of the state as well as create hatred and enmities among the different caste and communities. Hence the case.
