The caller claimed that they had detained all of her belongings at an undisclosed location, further they asked her whether she belonged to Meitei or not. Later, on the same date at around 4:47 pm, one of her company staff informed her that her belongings had been unloaded from the Tata Truck by unknown individuals suspected to be Kuki volunteers or militants at an unidentified checkpoint on NH-2 at Sapermeina. The approximate value of the unloaded items and her properties i.e. unloaded is about Rs 2,22,900 and untraced till date.
