Today i.e. 04/08/2024 at 11:40 pm received an information that on the same at around 11:30 pm one Alto car B/Regn. No. MN06LB4457 driven by an unknown driver proceeding towards Wangjing side from Thoubal side collided with one Bullet Hunter B/Regn. No. MN04G5588 ridden by an unknown rider coming from opposite side in wrong direction along NH 102 near Midfield School, Wangbal due to rash or negligent riding on the part of the unknown rider of Bullet Hunter. As result of it, one unknown rider and one unknown pillion of Bullet Hunter sustained injuries on their persons and evacuated to District Hospital, Thoubal for giving medical treatment and pillion was
