Subject: First Information Report (FIR) Theft from Sub-Store, Power House Leimatak.

Sir,

I have the honour to state that on 04/07/2024 at around 5:00 Pm, received a report reported by Sh. CL. Khayuingam, Sr. Manager (E) stating that on 03/07/2024 at around 8:30 hrs, Sh. CL. Khayuingam, Sr. Manager (E) was going to the residence of Dr. Prasenjit Dhar, SDCMO. On the way to his residence, while passing by the sub-store, it was noticed that the CCTV camera installed in front of sub-store gate was hanging in opposite direction. On carefully observing the CCTV camera, it was found that two out of three support strings were found broken and LAN data cable was found cut just near the camera. Just after that, Sh. C.L. Khayuingam went to the entry gate of sub-store and found that the lock of the Iron Gate was found damaged and opened. The next wooden door was visible tempered and its wooden portion near the lock was found broken/damaged though the lock was intact and it's appeared there was forced entry into the sub-store.

The incident was telephonically intimated to snri Nitish Kumar, DGM(E). On his advice, Sh. C.L. Khayuingam, Sr. Manager (E), Sh. SatySrivastava, AM (E) and one senior official from CRPF, Shri Shiv Ram Meena, inspector and lalsom Gangte, Jr. post Commander, Home guard went to check the condition of the sub-store and found that one lock out of two locks of the sliding grill door was broken while the other lock was intact. A gap was found on the lower part of the sub-store sliding grill door which was wide enough for entry of a person. On observation of inside of the sub-store, some wooden boxes were found opened forcefully. Few ceiling fans (about10 nos) and some stator bars made of copper (about 24 nos.) which were housed in a wooden box were also found missing. Some other items like few rolls of copper winding wire, flexible copper wires were also missing.

Simultaneously, CCTV camera was checked and it was observed that the camera installed in front of the Leimatak Sub-Store stopped recording at 03/04/2024 00:07:11 Hrs. the recording of the camera was checked and it was observed that the recording stopped due to loss of connectivity. There is another camera installed inside the Sub-Store and the footage of the same was checked and it was found that 2 unknown persons broke into the sub-store and were trying to open the wooden boxes kept inside the sub-store. On further checking of the footage, it is observed that the unknown persons were taking out bags, crates/boxes and stator bars etc. The value of the missing items is approximatel rs. 20 Lakhs.
