Subject: Enquiry report.

Sir,

I have the honour to state that, on 30/06/2024, the individual namely Longjam Mangoljao Singh aged 34 yrs., s/o- Late L. Thoiba Singh of Kwakeithel Akham Leikai reported in writing with OC/Imphal PS stating that on the same day @ 2:30 pm, one Inao (full particulars not known) came to his rent house located at Kwakeithel Akham Leikai and requested to hire his Honda Pleasure, white in colour, bearing registration number MN01AB 7445 for his personal work. But, the individual had not returned back the vehicle till date. He also had phone call to his girlfriend from his mobile number 8787319019 but the call history was not found. It is therefore requested to recover his Honda Pleasure and take up legal actions against the culprit at the earliest. It refers to GD Entry no. 23/IPS/2024 dated 30/06/2024. During the course of enquiry, the individual namely Longjam Mangoljao Singh was examined properly in c/w the case and stated that one unknown person, who introduced himself as one Inao of Nambol Makha Leikai, came to his rent house located at Kwakeithel Akham Leikai on 29-6-2024 in a very distressing condition and was provided shelter at his room on humanitarian ground. On this day @ 11:30 pm, the unknown individual engaged to use the mobile handset of complainant having mobile no. 8787319019 and talked to one person suspected to be his girlfriend about an hour. Later, the unknown person deleted the call history and stayed the night at the rent house. On the next day i.e., 30-6-2024 @ 2:30 pm, the unknown person again requested him and hired his two wheeler Honda Pleasure vehicle bearing registration number MN01AB7445 but the vehicle had not be returned till date. Further, the identities of the unknown person or his whereabouts could not be traced out or contacted till date. During further enquiry, CDR (Call Detail Records) of the mobile number 8787319019 (mobile number used by the complainant) dated 29-6-2024 & 30-6-2024 were analyzed and the identities of involved culprit of the present referred case could be established. On 8-7-2024 @ 5:30 pm, the involved culprit namely Laishram Romen Singh aged 21 yrs., s/o- (L). L. Jugeshwor Singh of Nambol Makha Leikai was detained at Nambol Bazar through mobile location tracking and later brought to Imphal PS for further questioning in c/w the case. On initial questioning, the individual admitted the alleged charges leveled in the present case. He disclosed that he had mortgaged the said vehicle to one Thokchom Chand aged @ 23 yrs., s/o- not known of Nambol Kongkham Leikai at the cost of Rs. 15,000 (rupees fifteen thousand). As such, a thorough investigation is required to ascertain the facts of the case.

It is therefore submitting the enquiry report to kindly register a regular case against the individual namely Laishram Romen.
