Subject: An application filed for lodging of FIR in Cognizance Order by the Hon'ble Supreme Court dated 25-09-2023 in the Special Leave Petition (Civil) Diary No. 19206/2023 (Dinganglung Gangmei versus Mutum Churamani Meitei & Ors) and passed in the Order by the Governor of Manipur vide order No. H-3608/2/2023-HD-HD dated 10-10-2023 (copy enclosed) for protection of my house located at Canaan Veng North AOC, Imphal East, PO & PS- Imphal, Imphal East District, Manipur.

Sir,

I have the honour to state that on 3rd May, 2023, when the communal violence started in Manipur, my family left my house in Canaan Veng, North AOC in order to escape the crisis. I requested one family friend and a trustworthy Meitei man and his family to stay and look after my house. They (the Meitei family) stayed in my house as requested and my house and my properties were safe for more than one year.

However, yesterday i.e., 20th August, 2024 at @ 9:30 pm, I was informed that some unknown miscreants had called that Meitei man who stayed and looked after my house at **Arambai Tenggol** office and was beaten up for staying and protecting my house and my properties. They (**Arambai Tenggol**) threatened him not to stay further in my house and out of fear for his life, he left my house. So, presently I have no idea who is staying in my house and is now left unprotected. I don't know if my house is also looted or not or occupied by any unknown person(s) because I can't go there or send anyone but I highly suspected that my house might be already looted because I got a picture of my gate where "**AT**" is written in white colour which is said to be a sign of being occupied by **Arambai Tenggol** (picture enclosed). If it is looted, my properties estimated to be worth Rs. 3,00,00,000 (Three crores only) approximately would have been lost. If it is not stolen, I request you to please protect and secure my house as well as my properties inside my house, as ordered by the Home Department, Govt. of Manipur. I request you to please locate it and keep in your safe custody.

My humble request is to please take necessary action in all the above-mentioned matters for the ends of justice.
