With reference to Para No. 6 of the Detailed Status report on FIR No. 40(6)2020CCSP u/s 406/419/420/465/468/34 IPC & 66C/66DIT Act, under the heading of "Progress of Investigation," it was indicated that while the accused persons were in police custody, a formal discovery process was conducted u/s 27 of the IEA for the accused persons, namely G. Kamson and Kh. Boby Singh. During the process, the Yahoo mail account leitanthemramesh@yahoo.com, which is linked with the PMKISAN user accounts Impw02 of Imphal West and Impe02 of Imphal East District, was recovered from the accused G. Kamson. Furthermore, the details of the Gmail ID gkamson2017@gmail.com, which was previously linked with the PM-KISAN User IDs: gkamson2017@gmail.com, were found to have received OTPs to access the PMKISAN Impw02, Impe02, and NoneO2 during the period from June 2019 to January 2020. Kindly arrange to take necessary action to lodge a separate FIR against G. Kamson concerning the Imphal West User ID Impw02, Imphal East User ID Impe02, and Noney User ID None02 at the earliest.

2. Further, kindly refer to Letter No. 05/07/2017-DC-KCG/2597 dated 20.07.2020, addressed to the Officer-in-Charge, Cyber Crime Police Station Imphal, from the Deputy Commissioner, Kakching, regarding "Request: for investigation into unauthorized approval of PMKISAN beneficiaries-redg "User KAKCO9" (copy enclosed). Kindly intimate the status of the same to the undersigned at an early date.

Therefore, it is requested to kindly take immediate necessary action as proposed in Para No. 1 and Para No. 2 above at the earliest.
