Sir,

Cyber Crime Police Station, Manipur is enquiring a case on the basis of a report forwarded by OC/Moirang PS, wherein the complainant namely, Lourembam Ibosana Singh (40) S/o L.Tomcha Singh of Ngangkhalawai, Moirang stated that on 13/06/2024 at about 3.17 pm, one unknown youth who came at his jewellery shop located at Moirang Lamkhai asked to buy 2 (two) sana san (gold). He said he will pay the amount of the gold through Google pay. The complainant received a text message in his mobile number regarding crediting the said amount. Instead of transferring the amount, he sent a text message that an amount of Rs. 43,000/- has been credited into the complainant's mobile number, 8787440849 from one mobile number 9233577182. Later, the complainant came to learn that the said amount has not been credited and he has been cheated.

During the course of enquiry, examined the complainant and on checking his mobile phone, it is found that a forged credited transaction message was received from the alleged accused mobile number bearing 9233577182. A requisition has been sent to the Nodal Officer, LIU to obtain CDR/SDR and CAF of the mobile number bearing 9233577182 used by the alleged accused person.

Hence, a cognizable offense has been made out and it is therefore, submitted the report for kind perusal and necessary action.
