Romendro Singh, ASI. Ibomcha Soibam, team of Special Mobile Patrol Unit, Jiribam led by SI. A. Krishna Sharma, in-Charge, Special Mobile Patrol Unit, Jiribam, troops of 39 Assam Rifles led by Hav. Adhitya Kumar, troops of 87 Bn. CRPF led by Shri Tapan Kumar, Commandant 87Bn. CRPF and Shri Sanjay Singh, Deputy Commandant 87 Bn. CRPF and one platoon of 20 Bn.
