## 13. First Information contents:

The brief fact of the case is that on the 16th August 2024, the above noted vehicle New Mini Truck, Tata Ace Gold bearing Temporary Registration No. T0724AS9547A with the Chassis No. MAT559033RZE12745 and Engine No.700CC104EVXS58968 in empty was proceeding from Dimapur for Imphal and while reaching a location between Keithelmanbi and Bongmol village on NH-2 at around 9:30 pm, unknown miscreants stopped the vehicle. According to the driver namely Md. Merajul Haque (40) s/o Md. Abdul Rahman of Palahjuri Charaibahi, Marigaon, Assam, the miscreants blind folded him and his helper then, they forcefully took away the Mini truck before reaching Bongmol Village on NH-2 to unknown location; and threatened them that, if they don't go away, they will cut off their head and burn them alive. Fearing that, the driver along with his helper further proceeded towards Imphal in one auto-rickshaw and then proceeded towards Dimapur in one taxi on the following day. Hence A case under FIR 33(8)2024 KPI-PS u/s 126(2)/131/309/351(3) BNS has been registered for investigation.
