Base on specific input was shared by intelligent agency regarding the movement of unknown armed miscreants in the general area of Mission Veng (SQ14227) approx. 06 Kms North of COB Kangpokpi. In response to this information, a joint team comprising of 22 AR, C-119 CRPF and District Police Kangpokpi launched a search operation today i.e. 18/08/2024 at 0600 hrs to 0830 hrs. During the search operation conducted in the suspected area by the combined teams, the unknown armed miscreants were already fled away from the scene however; the following items were seized from the spot at 0810 hrs. The combined search operation was terminated at 0830 hrs.
