Complainant namely ASI. N. Ibotombi Singh of CDO Unit, Imphal East lodged a written report to OC/APS stating that on the 22th August, 2024 at about 2:00 p.m. received a reliable information from 5/9 GR corroborated with his own intelligence about the presence of some anti-social elements in and around Nungaipokpi Village, Imphal-East District. Based on the said information, a combined team of CDO/IE Unit and a column of 5/9 GR comprising of Sub. N. Bobo Singh of CDO/IE, Unit assisted by SI. Sh. Nikhil Singh of CDO/IE Unit and ASI. Md. Sakir Ahmed of CDO/IE under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops) Imphal East District conducted a searched operation in the general area of Nungaipokpi Village of Imphal-East District and its adjoining foothills at about 3:00 p.m. During the search operation, the under noted arms, ammunitions and explosives were found lying abandoned at a place which is about 500 meters above the foothill at the southern side of Thongkhong Kachin, Nungaipokpi Village, Imphal East District. The arms, ammunitions and explosives are (1) 1 (one) .32 pistol regd. No. K0266 with magazine (2) 1 (one) .32 Pistol with magazine (3) 1 (one) 12 bore Single barrel gun (4) 2 (two) nos. of No. 36 Hand grenade (5) 1 (one) no. of Chinese Live Hand grenade (6) 6 (six) nos. of wood piercing shell (7) 15 (fifteen) nos. of blank cartridge (8) 3 (three) nos. of detonator (9) 1(one) no. of 2" Para Illuminating Bomb (10) 5(five, nos. of 12 bore double barrel live ammunitions (11) 3(three) nos. of arming ring (12) 3 (three) nos. of Smoke grenade (13) 4(four) nos. of WP Green No .80 MK1 (14) 3(three) nos. of anti riot shell. Accordingly, the said abandoned arms, ammunitions and explosives were seized at 3:45 p.m. from a place which is about 500 meters above the foothill at the southern side of Thongkhong Kachin, Nungaipokpi Village, Imphal East

District by observing due formalities. The above mentioned seized items are suspected to have been hidden by unknown miscreants for carrying out illegal activities. Hence, the case.



I have the honour to report that today i.e. the 22nd August, 2024 at about 2:00 p.m. received a reliable information from S/9 GR corroborated with our own intelligence about the presence of some anti-social elements in and around Nungaipokpi Village, Imphal-East District. Based on the said information, a combined team of CDO/IE Unit and a column of S/9 GR comprising of Sub. N. Bobo Singh of CDO/IE Unit assisted by SI. Sh. Nikhil Singh of CDO/IE Unit and ASI. Md. Sakir Ahamed of CDO/IE Unit under the command of Inspt. Kh. Henry Singh, CDO/IE Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops) Imphal East District conducted a searched operation in the general area of Nungaipokpi Village of Imphal-East District and its adjoining foothills at about 3:00 p.m.
