No. MN06SA-8577 (white) riding by my wife was rammed/dash by one unknown rider of Bullet Royal Enfield (black) bearing Regd. No. not known at Tinsid road near Chicken Centre due to rush or negligence drives on the part of Bullet Royal Enfield. As a result, my wife and son received injury on their persons and evacuated to JNIMS Hospital for medical treatment. The unknown rider of Royal Enfield fled away after committing the crime.

It is therefore, requested to you to kindly take up necessary legal action against the unknown rider of Bullet Royal Enfield according to law.


