Today i.e. 13/10/2024 at 9:20 am, received an information that on the same day at around 9:10 am, one Royal Enfield Bullet bearing registration No.MN04G-6341 coming from Khongjom side towards Thoubal side met an accident with one TVS moped black in colour bearing registration No. NIL along NH 102 at Tentha Lamkhai near YK College, Wangjing. As a

result of it, the rider and the pillion of the Royal Lattick as well as the rider of the TVS Moped received injuries on their persons and eviduated to District Hospital, Thoubal for medical treatment. Both the vehicles were partly damaged.
