Subject: Combing and search Operation Report.

Sir,

I have the honour to state that based on inputs of presence of arms and ammunitions which were hidden by some unknown person(s) in thickly forested area of L. Simol/Sijang Village, Churachandpur District, Manipur in the upper reaches of Thangjing ridge. A combing and search operation was launched from 0600 hrs to 0815 hrs on 12/09/2024 under the commander of Maj. Lokpal of Laigenpokpi COB, Lt. Gaurav Rathee of 5 Sikhs, AC Puneet Chopra of E 05 BSF and Thomas Haokip, MPS AC 1st IRB, CCPur. The team methodically swept through the area and found the following arms and ammunition Viz. 1. 1(One) no. of Rocket 7.5 feet, 2. 1(One) no. of large size country made mortar, 3. 3(Three) Med size country made mortar, 4. 1(One) no. of Med bomb launchers, 5. 1(One) no. of Modified M-16 rifle, 6. 4(Four) nos. of Bomb Launcher, 7. 3(Three) No. of Bomb country made mortar and the same have been seized under formalities on 12/09/2024 and handed over to OC/CCP-PS for safe custody and for further necessary action. During the combing and search operation no person was arrested.

The seizure of sophisticated rocket in the area have raise suspicion of the presence of other such rocket or illegal manufacturing unit in the area. District police are collecting information and in search of any other illegal arm as such there is a delay in filing of the operation report in time. Till date, no newly seizure of arms/Sophisticated rocket was made.

I, therefore kindly request you to take up necessary action as per law.
