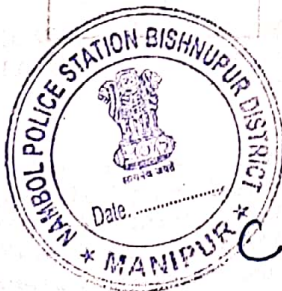

Subject: Report.

Sir,



I have the honour to report that today i.e. 26/04/2024 at about 10.30 am received a reliable information about the movement/ exchange of Narcotic & psychotropic substances somewhere in the general area of Govindagram under Wangoi Sub-Division. So, I immediately informed the said intel to the Superintendent of Police Bishnupur District, Manipur who authorised to organise a team to act on the said intel. I along with ASI. N. Robert Singh of BPR-PS including women police constable assisted by HC Phulendra Longjam of BPR-PS under the supervision of Shri Ksh. Ravikumar Singh, IPS, Superintendent of Police, Bishnupur District rushed to the said area after giving due information to the OC/NBL-PS for conducting frisking and checking at Govindagram Makha Leikai near Lai Haraopham at @ 11.40 am.

During the frisking checking, one Auto rickshaw RE bearing registration No.MN01AH-9633 and one Alto K10 silver in colour bearing registration No.MN06LB-8651 were intercepted at the same time by our police team which were coming from Nambol side on the spot at 1:10 pm. On asking the purpose of their travel, they could not give a convincing reply. So, further verification was conducted. The driver of the Auto rickshaw identified himself as Md. Abarar (40) S/o. Md. Ayajuddin of Porompat Thawanthaba Leikai, Imphal East and two lady passengers as Wahida (49) D/o. (L) Ahamad Ali of Lilong Haoreibi A/P Hatta near Oil pump and her daughter Ruksana (21). Further, the driver of the Alto K10 identified himself as Yumnam Ajitkumar Singh (38) S/o. Y. Rameshwar Singh of Irom Meijrao Maning Leikai and co-driver as Pebam Maheshwar Singh (38) S/o. (L) P. Rajen Singh of Govindagram Makha Leikai.

On verification of the drivers and occupants of the both the vehicles, they were acting very suspiciously and tensed. On seeing their attitude, it is highly suspected that they might possessed some illicit or contraband items. So, I and my team felt the need to make a search of their persons as well as the vehicles. All the five of them were given the option if they want their body search in presence of a Magistrate or a Gazetted Officer, in writing, to which they opted for the latter.

Immediately, informed the matter to Shri Laishram Khogen Singh, MPS, SDPO-Bishnupur to be present at the spot. Subsequently, he arrived at the spot at @ 2.40 pm and conducted search of persons and vehicles by our police team including lady police personnel.

On body search of Mrs. Wahida by lady police personnel, two cartoon boxes were found inside her floral printed carry bag. On opening the two-cartoon box, 3(three) nos. of plastic pouch and another 17(seventeen) nos. of plastic pouch suspected to be No.4 Herion powder were found respectively. And on weighing of the total 20(twenty) nos. of plastic pouch containing suspected No.4 heroin powder by using digital Weighing machine, is found to weigh 238 grams approx. (including weight of plastic pouch). One Samsung keypad mobile phone having mobile no.9233684486, one partly broken Samsung mobile handset having mobile no.9366896605, one Xiaomi mobile handset having mobile No.8794841129 one Pan card having no.AEZPW7569R in name of Wahida, one SBI master card having no.5596 0101 4987 6029 in name of Wahida & one Amway card having no.S00088766505 were also found from her possession.

On spot questioning, it is revealed that the above driver and co-driver of the Alto K10 car have conspired for trafficking the illicit items/drugs

On body search of Ruksana by lady police personnel, one 1+ mobile handset having mobile no.7085264461 was found.

On body search of the Auto driver namely MD. Abarar, one Aadhaar card b/no.8566 5396 5280, one PAN card having no. CJJPA4943E, one RC book of Bajaj Auto b/no.MN01AH-9633, one SBI ATM card b/no.4591 5600 3888 4805, Rs.4000/- by cash, and one POCO mobile handset having mobile no.9362807099

On body search of the driver of Alto K10 namely Y.Ajitkumar Singh, one Aadhaar card b/no.701168405705, one service ID card of Y. Ajitkumar Singh, one PAN card having No.ELPPS2335A, one SBI debit card having no.6522 9402 7021 1264, one Driving License bearing No.MN-0620170017062, one RC Book of Alto K10 b/regd.No.MN06LB-8651, One SBI debit card b/no.4591 5603 2676 1715 and Rs.1500/- by cash were found inside his brown colour wallet. One Redmi mobile phone having mobile No. 8974467521.

On body search of co-driver of Alto K10 namely Pebam Maheshwar Singh, one Samsung mobile handset having mobile 9862959048 & 9402712673 and one realme mobile handset having mobile no. 9233865697, one Pan card b/no. DUJPS8859H, one SBI ATM card having no.4592 0000 0833 1619, one SBI ATM card having no.4591 5602 0562 2087, one Aadhaar card bearing No. 3778 6678 0684, one driving license b/no. MN-0520080022034, one Service ID card of P. Maheshwar Singh and Rs. 530/- by cash were found inside his brown colour wallet.

Thereafter, 20(twenty) nos. of plastic pouch suspected to be Herion powder along with one Samsung keypad mobile phone having mobile no. 9233684486, one partly broken Samsung mobile handset having mobile no.9366896605, one Xiami mobile handset having mobile no.8794841129 one pan card having no. AEZPW7569R in name of Wahida, one SBI master card having no.5596 0101 4987 6029 in name of Wahida & one Amway card having no.S00088766505 were seized from the possession of Wahida by preparing formal seizure memo at 3.00 pm in presence of independent witness.

One 1+ mobile handset having mobile no.7085264461 was seized from the possession of Ruksana at 3.10 pm.

One Bajaj Auto b/no.MN01AH-9633, one Aadhaar card b/no.8566 5396 5280, one PAN card having no.CUJA4943E, one RC book of Bajaj Auto b/no.MN01AH-9633, one SBI ATM card b/no.4591 5600 3888 4805, Rs.4000/- by cash, and one POCO mobile handset having mobile no. 9362807099 were seized from the possession of MD. Abarar by preparing a formal seizure memo at 3.20 pm.

Further, one Alto K10 silver in colour bearing registration No.MN06LB-8651, one Aadhaar card b/no.701168405705, one service ID card of Y. Ajitkumar Singh, one PAN card having No.ELPPS2335A, one SBI debit card having no.6522 9402 7021 1264, one driving License bearing No.MN-0620170017062, one RC Book of Alto K10 b/regd.No.MN06LB-8651, One SBI debit card b/no.4591 5603 2676 1715 and Rs.1500/- by cash were found inside his brown colour wallet. One Redmi mobile phone having mobile No. 8974467521 were seized from the possession of Y. Ajitkumar Singh at 3.30 pm

And from the possession of co-driver of Alto K10 namely Pebam Maheshwar Singh, one Samsung mobile handset having mobile No. 9862959048 & 9402712673 and one realme mobile handset having mobile No.9233865697, one Pan card b/no.DUJPS8859H, one SBI ATM card having no.4592 0000 0833 1619, one SBI ATM card having no.4591 5602 0562 2087, one Aadhaar card bearing No. 3778 6678 0684, one driving license b/no.MN-0520080022034, one Service ID card of P. Maheshwar Singh and Rs. 530/- by cash inside one brown coloured wallet were seized at 3.40 pm.

The above seized 20(twenty) nos. of plastic pouch suspected to be Heroin powder were packed with a white cloth and sealed is marked as "X" in presence of Gazetted Officer, Shri Laishram Khogen Singh, MPS. SDPO Bishnupur at the spot.

Accordingly, 1) Wahida, 2) Ruksana, 3) Abarar, 4) Y. Ajitkumar Singh and 5) P. Maheshwar Singh were arrested at 3.55 pm, 4.00 pm, 4.05 pm, 4.10 pm and 4.15 pm respectively from the spot by observing necessary formalities and the arrested persons along with the seized items are handed over to you for further necessary action.
