Sir,

I the undersigned have the honour to report that in view of current prevailing law and order situation and to detect any kind of illegal and snatched weapon, incriminating articles concealed and to sanitize the areas properly, today i.e. 05.05.2024 at around 6:30 am, under the supervision of Ksh. Ravikumar Singh, IPS, SP Bishnupur and Amarjit Lamabam, MPS Addl. SP (Ops) Bishnupur conducted a joint cordon and search operation at the adjoining foothill area between Aimol village and Irengbam Maning by a combined teams comprising of District Police Bishnupur led by Sub. Y. Sakti Shen, OC-CDO BPR, assisted by SI. Ph. Sunil Singh, Hav. No. 15007648 RK. Manjit Singh and Hav. No. 132001230 H. Nungshithoi Singh, a team of Nambol PS led by ASI K. Jiban Singh and a team of 59 GR in presence of the Executive Magistrate Shri Bijoy Nongmaithem, SDC, Dimas. During the search, 6 (six) nos. of gunny bags were found concealed inside the bushes of Sanlam Mapal canal. On opening the above mentioned bags, the following weapon, ammunitions and war like store were recovered.

- (1) 01 (one) no. of 9mm Service CMG with two empty Mag (Regn No -CC4030).
- (2) 01 (one) no. of 9mm Pistol with empty Mag (Regn No -77700).
- (3) 04 (four) nos. of 36 Hand Grenade live.
- (4) 41 (forty one) nos. of 7.62mm live rounds.
- (5) 32 (thirty two) nos. of 5.56mm live rounds.
- (6) 05 (five) nos. of 9mm live rounds.
- (7) 04 (four) nos. of .32 mm live rounds.
- (8) 05 (five) nos. of PEK Sticks weighing approx. 0.750 kg.
- (9) 06 (six) nos. of SLR tube launchers.
- (10) 01 (one) no. of No. 75 Detonator.
- (11) 08 (eight) nos. of 36 Hand Grenade arming ring.
- (12) 02 (two) nos. of Ballistic Cartridge.
- (13) 01 (one) no. of Tear shell.
- (14) 01 (one) no. of C-90 MK 3 grenade.
- (15) 02 (two) nos. of No. 80 Grenade MK-1 (WP)
- (16) 01 (one) no. of Bicard Strip and
- (17) 02 (two) nos. of walkie-talkie with one charger.

The above mentioned items which were suspected to be hidden by miscreants were seized at 7:30 a.m. in presence of the Executive Magistrate by observing formalities and handed over to Nambol PS for further necessary action.
