Sir,

With due respect, I the undersigned have the honour to report that, today i.e. 09/05/2024 at around 10:20 pm, while I was staying at my house, some unknown miscreants numbering around 5-6 persons forcibly entered my house. They were holding sophisticated arms like AK-47 and small arms. When I along with my wife confronting with one of the unknown miscreants, my son namely, Aheibam Nelson Singh, aged about 33 years was pulled out from his room on gun point by two of the miscreants. When my son shouted for help, they assaulted him by using butt of small arms on his head and he got bleeding injury on his person. I along with my wife resisted them and asked reason for his arrest and also to identify their identities. But they assaulted us by kicking and punching and we also got injured. In the meantime, some nearby localities rushed to our house. Immediately, the unknown miscreants escaped from the crowed by firing two rounds and quickly fled away by abducting my son on a MG Hector Vehicle white in colour bearing regn. No. Nil. I could not identify them as they all concealed their face with masks.

It is, therefore, request you kindly find out my son and take up necessary legal actions against them in the interest of natural justice.
