Madam, I am writing to you dire circumstances to seek your urgent intervention in a matter of grave concern. My name is Khundongbam Ningol Hidangmayum Ongbi Roshibala Devi alias Abema. aged about 26 years, and *I am the legally wedded wife of Shri Hidangmayum Sachin alias Tomba Sharma, accused no.1* in this complaint. Since our marriage on February 23, 2024. I have been subjected to continuous assault and harassment by my husband and his family members, who are more fully described in the subject above. I and my husband: accused No. 1 had been in a committed relationship for six years before our marriage. During the course, I once decided to end the relationship with him after discovering that he was publicly detained with a married woman for having an illicit relationship. His family concealed this disgrace with money, which further added to my sense of betrayal. Despite this, accused No.1 who is five years older than me, ultimately manipulated and eloped with me, making a mockery of my trust and commitment. Our long-standing relationship also met with severe opposition from his family due to class prejudice against their Brahmin background and my belonging to Meitei. Since our marriage, I have endured ongoing abuse from both my husband and in-laws, with my husband subjecting me to frequent physical assaults and emotional neglect instead of offering support and protection. These assaults include spitting on my face violently strangling me and forcefully pushing me onto the bed, leaving me in a state of constant fear. He only used me to fulfil his own needs, always making sure to use protection to prevent pregnancy. When I tried to object, I was violently beaten and slapped into silence, forced to endure his brutal behaviour. I was trapped in the house, stripped of any emotional or social support. This was not the relationship between a husband and wife. I felt like a sex slave, trapped in a situation where I was completely betrayed and exploited. On August 3, 2024, I fled to my parental home due to severe assault and threats from husband anticipated by in-law: accused persons to get

out of their house or face dire consequences. However, when my family and relatives attempted to address this issue peacefully by visiting the house of the accused persons in the evening of the same day, they were met with unprovoked brutal violence from the accused. My Family- parents, uncles, and cousins, were brutally assaulted with deadly weapons and required medical treatment at Thoubal Hospital at Khangabok. The accused not only attacked my family but also threatened legal action and falsely accused my family of harming them. Their violent preparation aimed to escalate the situation rather than resolve it. The accused have not only inflicted physical harm but have also engaged in discriminatory practices, including untouchability, which is not only illegal but also a grave violation of my fundamental rights. The behaviour of the accused constitutes a severe breach of trust, inflicted grievous hurt with intent to cause death, outraged my modesty of being a woman, and abetting me to return to my parent's home leaving me and my family in a state of profound distress. This is the accurate example of cruelty by my husband, and his family members towards me. I am submitting this complaint later than I would have liked due to the hospitalization of my parents, uncles, and cousins following the incident. During their recovery, I was unable to attend to this matter, but now that I am able, I am addressing it as a priority. Also, the persistent rejection and aggression of the accused: especially my husband (accused no.1) have only compounded the injustice and violence faced by my family and me. I have concerns regarding the accused individuals as they have been physically abusive towards me without provocation. Given these harrowing circumstances, I urgently request you to take immediate action. It is critical that the accused be detained and appropriate legal measures be taken to ensure our safety and obtain justice. Otherwise, I will suffer an irreparable loss which cannot be compensated by any other means. I trust in your prompt and decisive action to address this urgent matter and restore justice.
