Subject : Report.

Sir,

With due regards, I beg to state that today on 21/09/2024 at about 3.40 a.m received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foothill of Fungei Ching, Ngamuleirou Changbi Ngamukhong for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 5/9 Gorkha Rifle led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 4:20 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 2 (two) SMG Carbine with magazine bearing registration numbers 18250876 and 15505876, (2) 1(one) 12 Bore single Barrel Gun bearing registration number P 14255, (3) 1(one) 9mm pistol with magazine bearing registration number A-4152, (4) 1(one) .32 pistol with magazine bearing registration number Z-2412, (5) 5(five) nos. of 36 HE Hand Grenade, (6) 4(four) nos. Arming ring, (7) 2 (two) nos. of Tube launching, (8) 8(eight) nos. of 9mm live rounds, (9) 1(one) no. of .32 live round, (10) 2(two) nos. of 12 Bore live Cartridge, (11) 1(one) no. of detonator, (12) 2(two) nos. of BP iron plate, (13) 1 (one) no. of BP Jacket and (14) 1(one) no. of Tear Smoke Grenade, (15) 2(two) nos. of Stun Shell, (16) 1(one) no. of Tear Smoke Shell and (17) 1(one) no. of Walkie Talkie Baofeng radio set from the spot at 4:52 am. The massive searched Operation was conducted from 4:20 am to 6:00 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
