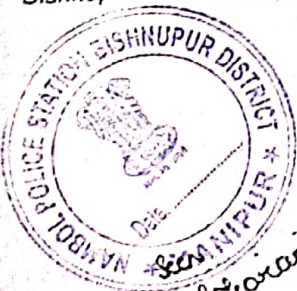

Subject: Report.

Sir,

I have the honour to report that today i.e. 15/05/2024 at about 6:35 am, self along with CDO team BPR conducted normal frisking and checking at Tera Urak frisking/ checking point, Bishnupur. In that time one Astar car white in colour bearing regd. no. MN03P/3403 proceeding from Bishnupur side towards Imphal signalled for stop, but the vehicle speeded up from the frisking point. In no time, our CDO frisking teams (self along with my team including two teams of CDO unit Bishnupur led by Hav. No. 15007648, RK. Manjit Singh, Hav. No. 1194122, Md. Rafik and HC. L. Gojendro Singh under the supervision of Subedar Y. Shaktishen Singh, OC/ CDO-BPR) followed the said vehicle. On the way, I also informed to Nambol PS through control room Bishnupur to detained the said vehicle. At around 6:48 am of the day, the said Astar car bearing regd. No. MN03P-3403 was intercepted at Nambol Maibam Chingning near Naoria stone crusher. In the meantime, a team of Nambol Police Station including lady constable arrived at the spot.

On checking, driver of the car and two lady occupants including one a minor child were found sitting inside the car. On verification, the driver of the car identities himself as Md. Sabir Khan (30) yrs S/o Md. Idham Khan of Kwakta Khuman Ward No.7 and the two occupants of the car also identified themselves as (1) Mrs. Ruksana (25) yrs, W/o Md. Sabir Khan of Kwakta Khuman Ward No.7 with her minor daughter, Mariya aged about 19 months and (2) Mrs. Rabina @ Thambal (48) yrs W/o Abdul Kalam of Kwakta Bazar Maning Ward No. 8 (mother of Ruksana).

On verification of the driver and occupants of the vehicle, they were acting very suspiciously and tensed. On seeing their attitude, it is highly suspected that they might possessed some illegal items. So, I and my team felt the need to make a search of their persons as well as the vehicle. All three of them were given the option if they want their body to be searched in presence of a Magistrate or a Gazetted Officer, in writing, to which they opted for the latter. So, I requested to Control room BPR to engaged one Gazetted Officer. After few minutes, Shri Laishram Khogen Singh, MPS, SDPO-Bishnupur arrived at the spot.

In presence of the Gazetted Officer, Shri Laishram Khogen Singh, MPS, SDPO-Bishnupur, with due respect the checking of the belongings of Mrs. Rukshana by lady police personnel in presence of witnesses. 03 (Three) soap cases containing suspected Heroin powder in plastic pouches were found inside her lady's hand bag dark blue in colour. Another 10(ten) soap cases containing suspected Heroin powder in plastic pouches were also found from the lady's hand bag maroon in colour marked as Fashion Italy of Rabina @ Thambal.

The soap cases containing Heroin powder detected from the possession of Mrs. Rukshana were marked as 1, 2 and 3 respectively in presence of witnesses. On weighing by using a digital weighing machine, it was found to be weight 12 grams, 11 grams and 11 grams excluding the weight of the soap cases respectively i.e in total 34 grams. Then, the above noted soap cases containing altogether 34 grams suspected Heroin power, One Aadhaar Card of Ruksana and one ladies hand bag dark blue in colour were seized by preparing a formal seizure memo at 0800 hrs from the possession of Mrs. Rukshana in presence of witnesses. Then, the three soap cases containing Heroin powder was put inside a carton box, packed and sealed properly with marked as "A". Subsequently, she was arrested at 0810 hrs.

Then, the 10 (ten) soap cases containing Heroin powder in plastic pouches detected from the possession of Rabina @ Thambal were also marked as 4, 5, 6, 7, 8, 9, 10, 11, 12 and 13 respectively. On weighing, package of the Heroin powder marked as 4, 5, 6, 7, 8, 9, 11, 12 and 13 were found to be weight 12 grams each excluding the weight of the soap cases and package marked as 10 was found to be weight 11 grams excluding the weight of the soap case i.e. in total 119 (one hundred nineteen) grams. The following items viz (1) 10 soap cases noted above (2) one MI Redmi 6A mobile handset with SIM card having mobile no. 7629944183 (3) One Aadhaar card recorded in the name of Thambal and (4) one lady's hand bag maroon in colour marked as Fashion Italy were seized from the possession of Rabina @ Thambal by preparing a formal seizure memo at 0820 hrs in presence of witnesses. Subsequently, she was arrested at 0830 hrs. Then, the 10 (ten) soap cases containing Heroin powder was put inside a carton box, packed and sealed properly with marked as "B". Subsequently, she was arrested at 0830 hrs.

From the possession of Mohammad Sabir Khan seized the following items at 0840 hrs viz (1) Astar car white in colour bearing regd. No. MN03P/3403 (2) one Aadhaar card of Mohammad Sabir Khan (3) One iPhone with SIM card having mobile no. 9863230295 and (4) Rs.160/- in cash with brown colour wallet. He was also arrested at 0845 hrs as he had full knowledge of the transportation of the contraband drugs noted above in conspiracy with his wife and mother-in-law.

Accordingly, the above accused persons along with the seized items are handed over to you for further necessary action.
