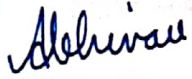
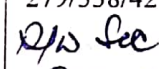

Today i.e. 17/05/2024 at 1:45 pm received a reliable information that on the same day at around 1:40 pm, one TATA Intra V10 bearing regd. No. MN01AA-5958 driven by one unknown driver which was proceeding from Utlou Awang side towards Tiddim road collided with one Honda Activa bearing regd. No. MN01AM-5785 ridden by one unknown rider which was proceeding from the opposite direction at Utlou Awang Leikai near the residential gate of Thingom Tomchou Singh along Utlou MDR road due to rash and negligent driving on the part of unknown driver and rider of both involved vehicles. As a result of which, the unknown rider and one pillion rider of Honda Activa received serious injury on their persons and evacuated to hospital for medical treatment. Both the involved vehicles were also partly damaged.

Hence, a regular case under FIR No. 22(05)2024 NBL-PS U/S 279/338/427 IPC is registered on suo moto for investigation.
