Sir,

With due regards, I beg to state that today on 22/08/2024 at about 3:30 a.m received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Tekcham Maning Ching waiting shed near hand pump for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 33 AR led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL and assisted by HC Kh. Rambai Singh under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 4:00 .am. by using metal detectors. On searching and found the undernoted articles i.e. (1) 1(one) no. of SGM carbine bearing registration No. 18251305 with magazine, (2) 1(one) no. of M20 pistol bearing registration No. 21078 with magazine, (3) 1(one) nos. of 9mm Pistol, made in Burma having body No. 1108 (4) 1(one) no of 9mm Pistol country made black in colour without registration No., (5) 1(one) no. of Bore Belt Action Rifle bearing registration No. 15732/2005 & butt No. 130, (6) 9(nine) nos. of 36 HE Hand Grenade, (7) 1(one) no. of 81mm Motar Shell (8) 2(two) nos. of Green 80MK (WP), (9) 1(one) no. of Tear Gas Grenade(10) 1(one) no of Tear smoke shell (11) 2(two) nos of Tear smoke shell Soft Nose (L/R), (12) 2(two) nos of Tear Smoke Shell (Chilli), (13) 2(two) nos of Tear Smoke Shell Soft Nose (Chilli), (14) 1(One) no of Stun Shell (Normal), (15) 1(one no of catridge having LOT No 41, (16) 10(ten) nos of .303 live rounds, (17) 3(three) nos of 303 blank cartridge, (18) 19(nineteen) nos of 7.62 mm live rounds, (19) 5(five) nos of 9 mm live rounds, (20) 3(three) nos of Catridge Signal 16 mm, (21) 1(one) no. of Baofeng Radio Set with charger and (22) a cash of 10,000 Kayts (ten thousand Kayts) note of Burmese Currency from the spot i.e. Tekcham Maning Ching waiting shed near hand pump at 5:54 am and seized at 6:15 am by observing necessary formalities. The massive searched Operation was conducted from 4:00 a.m. to 7:30 a.m. on the In in the dinner of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
