That, the humble complainant is the bonafide citizen of India and a resident of kodompokpi Mamang Leikai, PS-Nambol, Imphal West, Manipur - 795009 at present residing at (C/o Maibam Lalmani Singh) Heirangoithong Maibam Leikai, PO-Manipur University, PS-Singjamee, Imphal West Dist, Manipur - 795003 as such she is entitled to get the benefits under the law of the country.
2. That, the accused person is residing at kodompokpi Mamang Leikai, PS-Nambol, Imphal West Dist. 795009.
3. That, the complainant is the legally married wife of the accused person. She got married with the accused person on 20th June, 2007 according to Manipur Hindu rites and customs, prevalent in Manipur Hindu Society in the presence of parents, relatives and well wishers, at parental home at Heirangoithong Maibam Leikai

PO- Manipur University, PS: Singjamei, Imphal West Dist, Manipur. And since then, she had started living together as husband and wife at the matrimonial home at Kodompolepi Mamang Leikai, PS: Nambol, Imphal West, Manipur - 795009.

4. That, due to certain family matters, strains developed in the mutual relations. And, on 2nd November, 2023 there was some quarrel between the complainant and the accused person and suddenly he had beaten her by kicking and punching. The accused person further asked the complainant to leave the matrimonial home immediately. The accused person further told that she would be killed one day if she stayed further in the matrimonial home. The complainant was very afraid that the respondent shall further torture her, thus the complainant left the matrimonial home for her parental home on 2nd Nov, 2023. Now, she is staying in her parental home at Heizangthang Maibam Leikai, PO-Manipur University, PS: Singjamei, Imphal West Dist., Manipur.
5. That, on 7th May, 2024 (Tuesday) at 3.00pm, while the complainant went to matrimonial home to collect some of her educational documents, she surprisingly, found preparation for marriage of the accused person with a lady namely Shongbam Matouleibi (23) DO. Th. Sana Singh of Chuachandpore Thengra Leikai at the residence of Hidam Sadananda at Heizangthang Mamang Leikai. Then, he got married with the lady by performing void marriage at Heizangthang on the day itself despite objections of the complainant.
- That, the accused person married the lady again during the complainant's life time legally married wife. Further, the marriage is against the complainant's consent. The accused person subjects the complaint to cruelty.
6. That, the complainant has been constantly treated with cruelty by the respondent in the matrimonial home including physical violence, sexual violence, Verbal and emotional violence as well as economic violence as the accused person was to in love affairs with others so that the complainant could not live and stay any longer in the matrimonial home.
7. That, on 7th May, 2024 the complainant filed written report of the matter to the OC, Nambol Police Station for taking necessary actions thereby endorsing copies of the same to (1) The DGP Manipur and (2) The Superintendent of Police (SP), BPR for kind information and necessary action. Further being aggrieved, the complainant on 14th May, 2024 filed written report in the matter to the SP Bishnupur

Dist. U/sec: 154(3) of the Code of Criminal Procedure, 1973 for taking necessary action. However, no appropriate action has been taken up.

8. That, the acts of the accused person amounts to marrying again during the life time of wife, subjecting a married woman to cruelty, criminal conspiracy to commit offence, common intention etc. The accused person committed chargeable offence under sections 494, 498-A, 120B IPC and the cause of action arose on 7th May, 2024 with aforesaid illegal acts and the same is continuing within the jurisdiction of Hon'ble court.

It is, therefore, prayed your Honoured be pleased to:-

- i) take cognizance of the case;
- ii) issue non bailable warrant of arrest against the accused person;
- iii) to pass any order/orders for giving direction to the concerned police station for investigation of the case and.
- iv) punish the accused person according to law for the ends of justice.
