Subject: Report

Sir,

With due regards, I beg to state that today i.e. 25/09/2024 at about 04:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives suspected to be service arms & ammunitions along Tekcham Maning Ching area for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 33 AR, Inspt. K. Nitaranjan Singh, OC/CDO-TBL, HC. Kh. Rambai Singh of CDO/TBL led by Inspt. N. Suresh Singh, OC/Yairipok PS under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL rushed to the spot immediately and launched a massive operation at 04:30 a.m. On searching the undernoted articles i.e. (1) One No. of 7.62 SLR along with empty magazine bearing body No. 15371574, (2) One No. of SMG carbine along with empty magazine bearing body No. 18251306, (3) One No. of SMG Carbine (country made) along with empty magazine bearing body No. 18260805, (4) One No. of .32 pistol along with empty magazine bearing body No. G/2563, (5) One No. of 9 mm pistol along with empty magazine bearing body No. K/6572, (6) One No. 51 mm Pera Bomb, (7) Four Nos. of 36 HE hand grenade without detonator, (8) Two nos. of tube launching, (9) Two nos. of Electronic detonators, (10) Five nos. of STARDYNE-90 Explosive weighing 125 gm each, (11) Five Nos. 7.62 mm ammunitions, (12) Two Nos. 5.56 mm ammunitions, (13) Five Nos. of .32 mm ammunitions, (14) One No. of Stun grenade, (15) One No. of Stinger grenade, (16) Two Nos. of 38 mm rubber bullets, (17) Three nos. of tear smoke shell normal, (18) One No. of Dummy shell, (19) One No. of Stun Shell, (20) Two Nos. of tear smoke shell soft nose, (21) One No. of tear smoke shell (LR) & (22) One No. of Baofeng shed were found from the spot at 06:00 am. Hence the above noted articles were seized at 06:10 am by observing formalities. The massive searched operation was conducted from 04:30 a.m. to 06:30 a.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
