Tomba Singh of Khagempalli Pankha, Imphal West District, Manipur was returning home from Ningthoukhong towards Imphal along Tiddim road by riding a TVS-NTORQ bearing Regd. No. MN06SH-7246. On reaching at Nambol Khori Leikai in front of Nambol Lairel Girl High School, the vehicle of my elder brother was dashed by one Honda DIO bearing regd.
