Sir,

I the undersigned have the honour to report that today i.e. 02/06/2024 at around 11:00 am I along with my local friend namely Maranmi Hungyo, aged about 38 years S/O Ngayopam Hungyo of Ngarumphung village, Senapati district went to Nambol in a Maruti Gypsy to purchase a Mahindra Thar which was uploaded for selling in the Social media platform *Facebook Market Place* by an unknown person using mobile number 6909720395. As per engagement with the unknown person to hand over the vehicle at Nambol Chingmang area, we reached Nambol Chingmang at around 11:40 am. When reaching Nambol Chingmang near the Khoriphaba playground, 4 (four) unknown persons coming in an Eco Van, silver in colour having roof rack bearing regd. No. not known had given signal to stop. Thereafter, they came down by holding long sophisticated weapons and took us at gun point to an unknown remote location, latter known as Pukhrambam Maning Leikai, Bishnupur district. They detained us there for around half an hour and forcibly took away a sum of Rs. 5 lakhs along with 2 (two) mobile handsets in overpower. After the commission of the crime, all of them hastily left the place towards eastern side in the same Eco van.

It is, therefore, requested to kindly take necessary legal action against the unknown culprits at the earliest.
