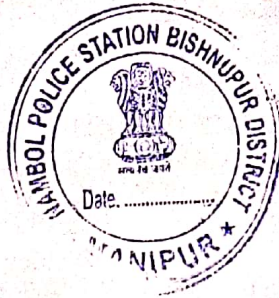

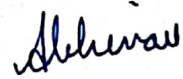

Today i.e. 02/06/2024 at 11:05 pm received a reliable information that on the same day at around 11:00 pm, one Mahindra Scorpio bearing registration. No.MN01AW 3031 white in colour driven by one unknown driver which was proceeding from Oinam side towards Imphal side collided with one Royal Enfield Bullet bearing regd. No. MN01AE 9662 grey in colour ridden by one unknown rider which was proceeding from the opposite direction at the middle of Nambol Bridge along Tiddim road due to rash and negligent driving on the part of unknown driver and rider of both involved vehicles. As a result of which, the unknown pillion rider of Royal Enfield Bullet was succumbed to his injury at the spot and the rider received serious injury on his person and evacuated to hospital for medical treatment. Both the involved vehicles were also partly damaged.

Hence, a regular case under FIR No. 27(05)2024 NBL-PS U/S 279/338/427/304-A IPC is registered on suo moto for investigation.
