Today i.e. 17/06/2024 at 6:50 pm received a reliable information that on the same day at around 6:45 pm, one Scooter Vespa XSL bearing registration No. Nil ridden by one unknown rider which was proceeding from Imphal side towards Nambol bazar collided with one Maruti Alto car bearing regd. No. MN03A-7239 driven by one unknown driver which was proceeding from the opposite direction at Nambol near Irabot Statue along Tiddim road due to rash and negligent driving on the part of unknown rider and driver of both the involved vehicles. As a result of which, the unknown rider of Scooter Vespa sustained injury on his person and evacuated to hospital for medical treatment. Both the involved vehicles were also partly damaged.
