Today i.e 25/04/2024 received an information at 1:50 pm that on the same day at around 1:45 pm one unknown person was detained by the local peoples of Kwakta Ward No. 3 numbering about 300 (three hundred) at Kwakta Municipal Council Ward No. 3. The said detained unknown person allegedly came along with another 2 (two) unknown persons in a Gypsy Vehicle and they have snatched away one 2 (two) wheeler vehicle of one unknown person of Kwakta. It was alleged that the other 2 (two) unknown persons escaped with the said snatched 2 (two) wheeler vehicle. Therefore, the crowd turned into unruly mob like situation and burnt down the Gypsy and the unknown detained person was assaulted by the local peoples and was received injury on his person. Later on, at around 4:30 pm the mob was dispersed by using tear smoke shells, mob bombs and some live rounds (blank fire) and the unknown detained person was rescued by security personnel timely and brought into the custody of PGCI-PS safely. Thereafter, the unknown injured person was evacuated to Community Health Centre (CHC), Moirang for medical treatment. Further, there is no other casualty or injury reported.

Hence, a suo-moto case under regular FIR No. 33(4)2024 PGCI-PS u/s 143/342/325/435/34 IPC has been registered for investigation.
