Sir,

I, the undersigned complainant is the owner of the Vehicle Goods Carrier, Xenon Yodha white in colour bearing Regd No. MN02D/0154, Chassis No. MAT464608JSD04624 and Engine No. 4SPCR10CRY617799.

That, on 10th Feb. 2023 the above mentioned vehicle was hired by one person namely, Konthoujam Thounaphaba Khaba aged about 32 yrs s/o K. Rajen Singh of Kodompokpi Maning Leikai, Mekola Imphal West District, Manipur-795140. I handed over the vehicle at his resident on verbal agreement that he will give Rs. 28,000/- per month to me as hiring charge for every month.

That, Konthoujam Thounaphaba Khaba had given a sum of Rupees 56,000/- for two months as hiring charges after that, he has not given any amount to me. On asking the reason for not giving the hiring charges, he has always given the false excuses. While enquiry, it came to know that, the vehicle had been mortgaged or sold out by Konthoujam Thounaphaba Khaba in collusion with one Yendrembam Deben Singh aged about 55 yrs s/o (L) Y. Tompok Singh of Bamdiar Mayai Leikai to unknown person without my consent. The approximate value of my vehicle is Rs 8,00,000/- (eight lakh) only.

It is therefore requested kindly trace out the said vehicle and book the culprits as per law.
