Today i.e. 12/7/2024 at 1:40 pm received a reliable information that on the same day at about 1:30 pm one Mahindra Thar, Black in colour bearing regd. No. MN01AS-4786 driven by one unknown driver which was proceeding from Imphal side towards Nambol dashed to the right side of one Honda Activa, Blue in colour bearing regd. No. MN01AF-8140 which was also proceeding in the same direction at Malom Awang near the gate of 165 Infantry Battalion TA along Tiddim road, due to rash and negligent driving on the part of the unknown driver of Mahindra Thar. As a result of which, the unknown rider and the pillion rider of Honda Activa sustained injuries and evacuated to hospital for their medical treatment. Both the involved vehicles were also partly damaged.

Hence, a suo moto case under FIR No. 35(7)2024 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
