

Subject: A humble belated Application of the undersigned Applicant who is one of the Victims of Riot starting from the 3rd day of May, 2023 at the Phougakchao Ikhai, Bishnupur District, Manipur coupled with a prayer to lodge a Zero F.I.R.



Sir,

With due regards, I, the undersigned Victim of the recent Riot, have the honor to lay down the following few lines for your kind consideration and necessary actions.

1. That I and my family members are the Victims of the Riot happened at the Bishnupur District on 03/05/2023. My family members consist of 5 members including myself (head of the family), my wife namely Ningombam Ongbi Priyanka (28 years), my son namely Ningombam Thoison Singh (7 years), my daughter namely Ningombam Riyanganbi Leima (3 years), my brother namely Ningombam Bishorjit Singh (25 years).
2. That I myself and my family members have been settling at the **Phougakchao Ikhai Maning Leikai, Tehsil – Kumbi, Bishnupur District, Manipur**, Pin. No. – 795133, by owning a piece of land there. I myself and my family members are the permanent settlers of the **Phougakchao Ikhai Maning Leikai, Tehsil – Kumbi, Bishnupur District, Manipur**. We even cast our votes there and we have been recognized by the Government as the permanent Settlers of the **Phougakchao Ikhai Maning Leikai, Tehsil – Kumbi, Bishnupur District, Manipur** by issuing Voter I.D. Cards and Aadhaar Cards etc.
3. That my Village is surrounded by Kuki Communities on the Southern, Eastern and Western side and by Muslim Communities on the Northern Side.

4. That on 03/05/2023, the "All Tribal Students' Union, Manipur" organized a Rally in the name and style of "The Tribal Solidarity Rally" and unwanted Riot happened. Being afraid of losing our precious lives, I myself and my Family members fled from our residence without taking anything with us except our wearing apparels. I have seen the unwanted incident of burning our house by Kuki Communities. I knew some of the persons of Kuki Communities which are resides next to our village namely Lalminthang, Sangsolen, Thangkhulen and others burning our Houses. They pelted stones and even fire gun shots on the Meitei Community on that day dated 03/05/2023. The miscreants looted our house and took away all the valuable belongings and later, our house was torched and gutted to ashes.
5. That I myself and my family have lost our dwelling house (Kutchu) constructed by us at our costs worth about Rs.4,00,000/- (Rupees Four Lakh Fifty Thousand); 150 Paddy Bags worth about Rs.1,35,000/- (Rupees One-Lakh and Thirty-Five Thousand); Clothes worth about Rs.1,00,000/- (Rupees One Lakh); Furniture (2 Beds, 3 Almirah, 1-Set Sofa, Dressing Table etc.) worth about Rs.6,00,000/- (Rupees Six Lakh); Gold Ornaments (Necklace of 1½ Mohor, Earring of 2 Mohor and Bracelet of 6 Mohor) worth about Rs.7,56,000/- (Rupees Seven Lakh and Fifty-Six Thousand); Utensils worth about Rs.25,000/- (Rupees Twenty-Five Thousand); Electronic items (Washing Machine, Flat T.V., Fan, Rice Cooker, Boiler etc.) worth about Rs.1,00,000/- (Rupees One Lakh); 1 Cow worth about Rs. 45,000/- (Rupees Forty-Five Thousand); 1 Calf worth about Rs.15,000/- (Rupees Fifteen Thousand); 6 Pig worth about Rs.1,80,000/- (Rupees One Lakh and Eighty Thousand); 2-German Shepherd (Dog) worth about Rs.30,000/- (Rupees Thirty Thousand); Poultry (30 ducks and 20 hens) worth about Rs.50,000/- (Rupees Fifty Thousand); a small home Temple and all Documents which is unaccountable. I myself and my family members have lost properties worth about **Rs.24,36,000/- (Rupees Twenty-Four Lakh and Thirty-Six Thousand)**. At present, I myself and my family members are taking shelter at a rent at Sagolband, Imphal West District, Manipur since, all the Shelter Homes/Relief Camps are full and out of capacity for adjusting me and my family members. We have lost everything we owned

since, we ran away from our house only with our wearing apparels and we are living in a very pathetic condition.

6. That I myself and my family members would like to lodge a F.I.R. case. Hence, the petition.

7. I was late due to out of station for earn money for my family.



In the light of the aforesaid facts and circumstances, Your Good-Self may graciously be pleased to lodge a F.I.R. Case for the losses incurred by me and my family members in the said Riot in the interest of Good Governance and on humanity ground.

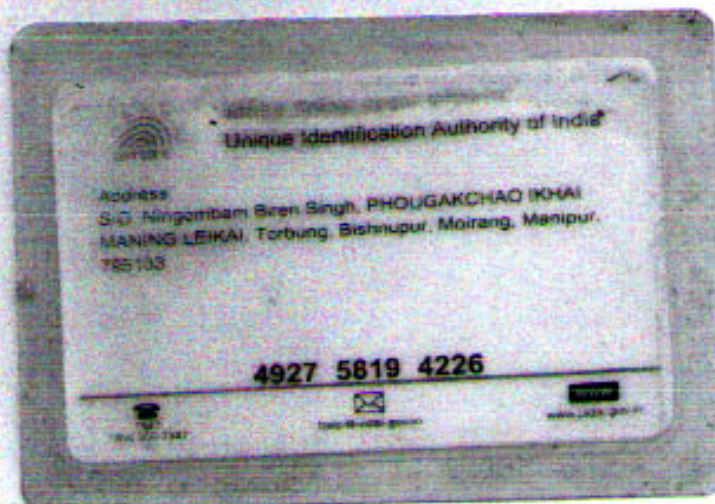
