

Subject: - Report.



Sir,

I am to report that, yesterday i.e. 27/05/2024 at around 10.35 pm on received of a reliable information about the movement of some armed miscreants in and around IVR of Terakhongshangbi - Santhong and Moirang Khunou. Based on the information, a joint team of CDO/BPR under the command of Sub. Y. Shaktishen Singh, OC-CDO Bishnupur led by Shri D. Robinson, MPS, DSP(CDO-II)/BPR under the supervision of Amarjit Lamabam, MPS Addl. SP (Ops) Bishnupur and under the overall guidance of SP-Bishnupur with a column of 16th Kumaon Regiment conducted frisking and checking at some strategic check points like Kwakta Maronglou, Terakhongsangbi, Phougakchao Ikhai etc.

During the course of frisking and checking along Kwakta Maronglou along the IVR one Suzuki Maruti 800 dark blue in colour coming from Santhong side toward Terakhongshangbi side in a suspicious manner was given a signal to stop for checking. Instead the car speeds up as it tries to escape from the frisking team. Immediately other teams were alerted and our team led by myself chased the vehicle and overtake the vehicle and forced to stop at Terakhongshangbi ward no. 1 near the canal. On seeing the teams from different directions, two persons drove down from the vehicle and try to run away taking the advantage of darkness. However, our team could overpower one of them by firing few rounds in the air while the other person run away taking advantage of the darkness. On checking his body, one wallet brown in colour containing one aadhaar card, one pan card, one driving licence, one voter ID card, Rs. 500/- in cash and one mobile phone was recovered.

On spot verification, the miscreant identified himself as Laishram Rabi Singh (33) S/O L. Tomba Singh of Moidangpok Mayai Leikai, Imphal West District. On questioning, he disclosed that, the escape person is one Priyo of Moirang. Further on checking the car, 1(one) M-16 rifle marked as PROPERTY OF U.S. GOVT. M-16 A1 CAL. 5.56 MM 4932006 with one magazine loaded with 8(eight) live rounds of 5.56 mm ammunitions was recovered from the dingy and 1(one) 9mm pistol (country made) with one magazine loaded with 2(two) live rounds of 9mm ammunitions was also recovered from under the front left seat. So, he was arrested from the spot i.e. Kwakta Terakhongshangbi ward no. 1 near canal (KMC) at 11.15 pm and seized the above mention recovered items i.e. 1) 1(one) M-16 rifle mark as PROPERTY OF U.S. GOVT. M-16 A1 CAL. 5.56 MM 4932006 with one magazine loaded with 8(eight) live rounds of 5.56 mm ammunitions, 2) 1(one) 9mm pistol (country made) with one magazine loaded with 2(two) live rounds of 9mm ammunitions, 3) 1(one) Suzuki Maruti 800 dark blue in colour B/Regd. No. MN1A-9439, 4) one wallet brown in colour, 5) one aadhaar card, 6) one pan card, 7) one driving licence, 8) one voter ID card, 9) Rs. 500/- in cash and 10) one mobile phone having one Jio SIM card and one Airtel SIM card at 11.20 pm of by observing proper formalities.

The arrested person along with the seized items are handed over to you for taking further necessary legal action against him.
