Sir,

I have the honour to report that in view of current prevailing law and order situation and to detect any kind of illegal and snatched weapons, incriminating articles concealed and to sanitize the areas properly today i.e. 07/06/2024 at around from 2.00 am to 5.40 am under the supervision of Shri Ksh. Ravikumar Singh, IPS, Superintendent of Police, Bishnupur District and Shri Amarjit Singh Lamabam, MPS, Addl. SP(Ops) Bishnupur, joint cordon and searched operation was conducted by combined teams comprising of District Police Bishnupur led by D. Robinson, MPS, DSP(CDO-II), Bishnupur assisted by Sub. Y. Shaktishen Singh, OC-CDO-BPR, Hav. No. 1299055 Kh. Kunje Singh, Hav. No. 411807 N. Dayananda Singh, HC N. Manglem Singh a team of PGCI-PS and a column of 16th Kumaon Regiment in between general area of Terakhongshangbi-Santhong gap and in between Kwakta Ward No. 8 and Phoisenphai village under PGCI-PS jurisdiction. During the searched, 1) 01 (one) No. of SMG carbine (Bearing no. 16019287) with a magazine, 2) 04 (four) Nos. of No. 36 HE Grenade, 3) 02 (two) Nos. of 2" Motar ILLU Shell with cover and 4) 13(thirteen) Nos. of live .303 Ballistic cartridges were recovered from Terakhongshangbi and Santhong Gap near the Maronglou Canal and the same were seized at 2.55 am by observing proper formalities.

Further, the combined teams also recovered 1) 01 (one) No. of Pompi Motar (Local made), 2) 01 (one) No. of .303 Rifle (Bearing no. 89AB0214) with a magazine, 3) 01 (one) No. of IED, 4) 06 (six) Nos. of Detonator with a container, 5) 01 (one) Bushell Telescopic sight, 6) 01 (one) No. of tube launching Grenade, 7) 01(one) No. of No. 36 HE Grenade, 8) 02 (two) Nos. of 9mm ammunitions and 9) 10 (ten) Nos. of 12 bore cartridge from a drainage in between Kwakta ward No. 8 and Phoisenphai village and the same were also seized at 5.20 am by observing proper formalities.

The operation was concluded at 5.40 am and the seized items were brought and handed over to PGCI-PS for taking further necessary procedure.
