

That, for the past one year I had been running a Whole Sale Shop at Torbung Bazar, Bishnupur District, Manipur. However, due to sudden and unwanted ethnic clash by the Kuki that erupted since 03/05/2023 I have to run for our life along with my family members. In that incident, my Whole Sale Shop which was located at Torbung Bazar was looted by a huge number of Kuki community and its militants in the evening of 03/05/2023.

A list of the lost items with price and total value (prices) is attached here with overleaf.

Due to this unwanted incident, I left Manipur and stayed at the quarter of K.N Meitei, at Guwahati.

Recently, I along with my family members returned to Manipur and presently staying at Luxmi Bazar at the residence of aunt namely Yumnam Tombimacha Devi W/o (L) Y. Bheigya Singh. Due to this I could not report my complain report in time.

It is therefore, I do request to take up legitimate and legal action that the lost items be regained as per law for the act and punish the culprits involved,

I shall remain thankfull for all the time.
