In submitting herewith the inquiry reports with reference to the above G.D.No. and R.R. No. Regarding a complainant report lodged by one Md. Sadam Shah (28)yrs \$70 Md. Ayub Khan of Kshetri Awang Leikai. When I enquired the report it is established that on 20/07/2024 at around 1:30am one Md. Jahangir a Heirang aged about (30) yrs \$70 Md. Alam of Kshetri Awang Leikai near KYC ground and father of the complainant namely Ayub Khan quarrelled about some argument over silly matter in front of the shop one Epham Naocha (28) yrs, \$70 Md. Zakir Hussain of Kshetri Awang leikai. After exchanging some words between them suddenly Md. Jahangir a Heirang hit to whom using Betel nut cutter (Kwajab) on the head of the Ayub Khan several times. As a result of which Md. Ayub Khan got injured on his head and other parts of his body. Then he was evacuated to JNIMS Hospital for treatment.

Further, on 20/07/2024 at about 10:00am I have visited the house of Jahangir (a) Heirang to record his statement but he was not found in his house. So, I have informed his family member to appear before me. However he failed to appear before me so on the 21/07/2024 & 22/07/2024 I visited his house repeatedly but he was not found.

On further enquiry, recorded the statement of Md. Ayub Khan by recording video and he disclosed that on 20/07/2024 at 1:30 am. Md. Jahangir a Heirang assaulted him by using Betel Nut cutter (Kwajab) on which his person got injured. I have visited the spot i.e. shop of the Epham Naocha (28) yrs. so Md. Zakir Hussain of Kshetri Awang leikai by pointed out by the complainant for inspection and to seize the items but he was not at his shop. So, I could not seize any items.

On 22:07/2024 at about 6:30pm. I contact Epham Naocha personally on mobile phone, he stated that the incident was true and Jahangira. Heirang was the culprit and he also disclosed that the Betel Nut cutter belong to him (Epham Naocha (28) yrs). So, I convinced him to produce the weapon and the CCTV footage which is installing at his shop and also to record his statement so he agreed. As agreed by him I had visited his shop on 22:07/2024 a 7:00 pm to seize the related items and to record his statement. However, on reaching his shop he was not at there and his mobile phone also kept on switch off mode. So, I could not seize any items again. So, I myself served a summon to the I pham Naocha (28) yrs, so Md, Zakir Hussain of Kshetn Awang I cikar to appear before me on 23:07/2024 a 10:30 am. However he failed to appear before me so I pham Naocha is concealing the items cent out the Injury report of the injured person to concerned Hospital vide memo no. 726/PRT-PS/2024 Dated: 23:07/2024, but not

Sent out the Injury report of the injured person to concerned Flospital vide memo no. 726/PRT-PS 2024 Dated: 23 07,2024, but not yet received the result.

On the above facts and circumstances, OC PRT is therefore, requested to take necessary proceeding against the accused persons not to happened criminal breach of peace and disturbance of public tranquillity to save from the bloodshed and loss of precious human lives for the end of justice.
