Sir,

I have the honour to state that today i.e. 22/07/2024 at about 3:20 am, a reliable information was received from our own sources about the presence of some active cadres of PREPAK (Pro) organisation in and around Okram Chuthek Kitna Panung area of Imphal East District with a view to commit prejudicial activities like extortion from general public etc. Acting on the information, teams of CDO-IW led by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East Police control room at around 3:23 am and conducted cordon and search operation at Okram Chuthek Kitna Panung, Imphal East District. During that one unknown person was found in a very suspicious manner at the house of one Sapam Iboton Singh of Okram Chuthek Kitna Panung, Imphal East District. Due to his suspicious nature, he was detained at the spot for verification and checking. During spot verification and checking, he identified himself as Sapam Priyojit Singh (43 yrs.) S/o. S. Iboton Singh of Okram Chuthek Kitna Panung, Imphal East District and one Redmi Note 7 mobile handset along with one Jio SIM card bearing mobile no. 9366072145 (as disclosed by him) was recovered from his possession.

During preliminary verification, he disclosed that he is an active member of PREPAK (Pro) organisation and started working for the said organisation since January, 2024 and presently working under the command of one s/s Major Ngamba @ Bungcha @ Sapam Sanjoy (Ph. no. +917005696900 & +919774520063) from Okram Chuthek Kitna Panung, Imphal East District of PREPAK (Pro) organisation. Under the instruction of his commanders, he served monetary demands to various Government employees located in and around Imphal area and collected a total amount of around Rs. 3,10,000/- (rupees three lakhs ten thousands only) on different occasions since January, 2024 and he handed over the said amount of extorted money to his commander.

Hence, he was arrested from the spot at 4:12 am and the above recovered mobile handset was seized from the spot at 4:20 am by observing formalities.

Hence, the arrested person along with the seized article is handed over to you for taking further necessary legal action against him.
