That on 06-05-2023 at around 3:00 p.m. some unknown armed miscreants suspected to be Kuki Narco -Terrorist started attacking and burnt down house and looted all the household items, which is located at Torbung Govindpur Leikai when I was at Guwahati. Regarding the situation of my personal unavailability at my home I unable to report the incident which was happened and unable to register FIR against the incident.

So, the concern authority/ies may kindly register FIR of the above mentioned subject in the interest of our grievance and on humanitarian ground.
