**Subject: - Report.**

Sir,

I have the honour to state that today i.e. on 16/07/2024 at around 11:30 am joint teams comprising of PCCI-PS led by self (ASI Md. Ziaul Haque) coordination with D/71 CRPF led by Inspt. Arunkumar Toppu and a column of 16<sup>th</sup> Kumaon Regt. together carried out normal routine frisking checking duty in the fringe areas of Kwakta Ward No. 8 (KMC) paddy field. In the meantime, one unknown person was coming from Kwakta Ward No. 8 (KMC) towards Kwakta Pangal Lamkhai site. On searching his body, found 10 nos of soap cases containing suspected to be Heroin powder which was concealed inside his leggings. On verification, he identified himself as Phundreimayum Nawas Sharif aged about 23 years S/o Phundreimayum Anja Khan a residence of Kwakta Municipal Council Ward No. 8, PO-Moirang, PS-Phougakchao Ikhai, Bishnupur District, Manipur at present staying at the rented house of Abida W/o Md. Bala of Kwakta Ward No. 6 (KMC). I have requested 2(two) passersby civilian's namely Md. Majid Khan aged about 24 years S/o Md. Nahapik of Kwakta Terakhongshangbi Maning Leikai and Md. Abdul Majid aged about 26 years S/o Late Md. Abdul Manap of Kwakta Municipal Council Ward No. 3 respectively to be voluntarily witnesses while conducting all due formalities. We then took out the soap cases one by one in presence of civil witnesses and on opening the soap cases it is found reddish colour substance suspected to be Heroin powder. On further questioning, he disclosed that as instruction by one known person namely Md. Awash (9362095460) S/o Late Md. Abdul Khalik residence of Ward No. 2 (KMC), PO-Moirang, PS-Phougakchao Ikhai, Bishnupur District, Manipur to bring 10(ten) nos. soap cases from one known lady namely Chochon Haokip (8798618022) aged about 36 years W/o Lalboi Haokip @ Gojen residence of Phuisebung Village, near Phuoljang Village, PO/PS/District-Churachandpur, Manipur and further, he (Awash) promised to pay a sum of Rs. 500(five hundred) for each soap case as carrying charges after safely handed over the said soap cases to him. Thereafter for identification, I marked the 10(ten) soap cases marked as A1, A2 ... up to A10 respectively and then conducted weighing in presence of the two civil witnesses and the respective weight of the suspected Heroine powder are as follows, A1-13 grams, A2-12 grams, A3-14 grams, A4-13 grams, A5-15 grams, A6-12 grams, A7-13 grams, A8-13 grams, A9-12 grams and A10-12 grams and the total weight of the seized illegal drugs was found to be 129 (one hundred and twenty-nine) grams excluding the weight of the soap cases and again, it was put inside a cartoon box marked as 'A' and then wrapped with white cloth which was properly packed and sealed. Accordingly, the illegal drugs along with one mobile handset REALME C 30 model having mobile No. 6282111531 (JIO) and one Bluetooth neck band earpiece light grey in colour were seized from his possession in presence of the civil witnesses on the same day at 03:30 pm. Later on, he was formally arrested from the spot at 4:00 pm of the same day after observing all due formalities.

Subsequently, the arrested persons along with the seized items were brought to PS and handed over to OC/PGCI-PS with a written report for taking further necessary legal action against him as per law.
