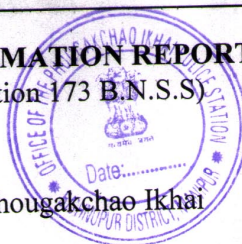

I was running a rice Mill at Torbung Govindpur Lane1, a few distance from my residential house and I got little earning from it.

In the month of June 2023, I went to Bangalore for seeking job as I have no any alternative way for earning in the Relief Camp. While staying at Bangalore, It was informed that my rice mill machine as well as rice mill shed were looted and destroyed by the unknown Kuki miscreants. The said criminal was suspected to have been committed by the unknown Kuki miscreants. The estimated amount of rice mill machine and shed damaged shed is about Rs. 5,80,000/-.

I could not report well in time due to tense prevailing law and order situation as well as I have been outside Manipur engaging in personal job.

It is therefore requested kindly to take necessary legal action against the culprits.

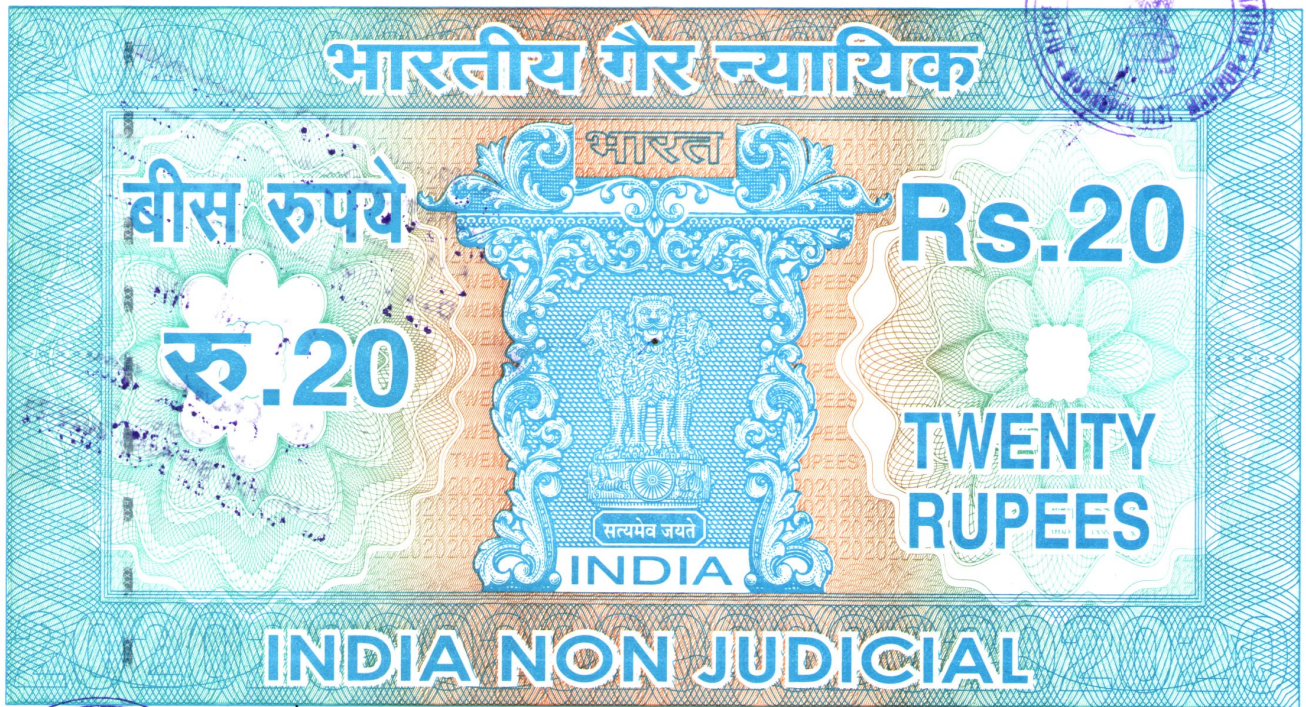

I, Mongsadam Priya Chanu, aged about 30 years, AADHAAR No. 9694 1595 732, D/O Mongsadam Tomba Singh, permanent resident of Torbung Gobindpur, Torbung, P.O. Moirang, P.S Bishnupur, Manipur, presently taking shelter at Kumbi Terakhunou Awang School Relief Camp, P.O. Moirang, P.S. Kumbi, Bishnupur District, Manipur, do hereby solemnly affirm and state on oath as follows:

1. **That,** I used to run a Rice Mill in my own homestead land under patta no. 1192/1314, covered by C.S. Dag No. 2208/2279 (Sht-1) measuring an area 0.075 acre of village no. 98-Torbung. This is true to the best of my knowledge.
2. **That,** since the ethnic clash erupted between Kuki community and Meitei community on 03/05/2023, I along with my family and other people of Meitei community fled the area for our lives leaving behind everything.
3. **That,** from a reliable source, I came to know that, the valuable things from my Rice Mill were looted burn down by the unknown Kuki Armed Miscreants.
4. **That,** I could not report the matter on time and lodge FIR due to tense situation at Relief Camp. This is true to the best of my knowledge.


