



In the month of June 2023, I went to Bangalore for seeking job as I have no any alternative way for earning in the Relief Camp. While staying at Bangalore, It was informed that my rice mill machine as well as rice mill shed were looted and destroyed by the unknown Kuki miscreants. The said criminal was suspected to have been committed by the unknown Kuki miscreants. The estimated amount of rice mill machine and shed damaged shed is about Rs. 5,80,000/-.

I could ot report well in time due to tense prevailing law and order situation as well as I have been outside Manipur engaging in personal job.

It is therefore requested kindly to take necessary legal action against the culprits.

That, I could not report the matter on time and lodge FIR due to tense situation at Relief Camp. This is true to the best of my knowledge.




